- 2. Describe the proper use of key vaccines, including but not limited to, influenza, pneumococcal, shingles, tetanus (Td/Tdap), human papillomavirus (HPV) and hepatitis B vaccines.
- 3. Utilize CDC recommendations to determine needed vaccines for a patient.
- 4. Identify resources to stay up-to-date on vaccine-related information.

#### Pharmacy Technician Course Objectives:

At the completion of this knowledge-based activity, the participant should be able to:

- 1. Identify vaccines commonly available at the pharmacy for childhood and adult immunization.
- 2. Understand the importance of the vaccine information sheet and requirements of its distribution.
- 3. Recognize successful methods and roles of the pharmacy technician for increasing access to information and provision of vaccines available at the pharmacy.
